

Regulations

of the Nobody Reads This: Art Book Fair

organised by the Ujazdowski Castle Centre for Contemporary Art
on 22—24 May 2026, hereinafter referred to as the “Regulations”

1. General Provisions

- 1.1. The provisions of these Regulations apply to participants of the event entitled: “Nobody Reads This: Art Book Fair”, hereinafter also referred to as the “Fair”, organised by the Ujazdowski Castle Centre for Contemporary Art, with its registered seat in Warsaw, at ul. Jazdów 2, entered in the Register of Cultural Institutions maintained by the Minister of Culture and National Heritage under no. RIK 15/92, Tax Identification Number: PL5260251285, National Business Registry Number: 000986159, hereinafter also referred to as the “Organiser”.
- 1.2. The Fair will be held from 22 to 24 May 2026, between 11:00 and 19:00, on the premises of the Ujazdowski Castle Centre for Contemporary Art at ul. Jazdów 2, Warsaw.

2. Fees for Participants

- 2.1. Admission to the Fair for Participants is free of charge. Participants interested in arranging a stand and presenting and selling publications on the Fair premises (hereinafter also referred to as the “Exhibitors”) are required to pay a fee, the amount of which depends on the size of the selected stand:
 - 2.1.1. small stand – half table (75×80 cm) – 300 PLN net / 369 PLN gros;
 - 2.1.2. standard stand – 1 table (150×80 cm) – 700 PLN net / 861 PLN gros;
 - 2.1.3. large stand – 2 tables (300×80 cm) – 1400 PLN net / 1722 PLN gros.All stands will be equipped with chairs (one chair for small stands, two chairs for standard and large stands) and access to electricity and Wi-Fi.
- 2.2. The Exhibitor is obliged to register for the Fair no later than 20 April 2026 by submitting the registration form available at <https://u-jazdowski.pl/en/nobody-reads-this-art-book-fair>, in which the Exhibitor indicates the size of the preferred stand.
- 2.3. The Organiser reserves the right to decide on admission to the Fair, as well as on the size of the allocated stand, provided that it will not offer a stand larger than the one indicated by the Exhibitor in the application form as preferred.
- 2.4. The Organiser will contact Exhibitors qualified to participate in the Fair by e-mail to the address provided in the application form.
- 2.5. On the basis of the information provided in the registration form, the Organiser will send the Exhibitor a pro-forma document, payment of which will guarantee the reservation of a place at the Fair, in accordance with the price list described in point 2.1 of the Regulations.
- 2.6. The Exhibitor undertakes to pay the fee referred to in point 2.1 of the Regulations within 14 days from the date of delivery of the pro forma document issued by the Organiser, by bank transfer to the account indicated in the document. To confirm payment of the fee referred to in point 2.1 of the Regulations, the Exhibitor undertakes to send the Organiser proof of transfer no later than 14 days from the date of receipt of the pro forma document, to the email address: targi@u-jazdowski.pl.
- 2.7. A VAT invoice will be issued by the Organiser after the Fair has taken place.
- 2.8. In the event of withdrawal from participation in the Fair, the Exhibitor is not entitled to a refund of the fee paid, referred to in point 2.1 of the Regulations.

3. Liability and Insurance of the Fair

- 3.1. The Organiser holds valid civil liability insurance for damages that may occur during the organisation of the Fair, subject to points 3.2.—3.5. of the Regulations.
- 3.2. The insurance referred to in point 3.1. of the Regulations does not cover property brought onto the Fair premises. Exhibitors may, at their own expense, insure publications, books, equipment, devices, exhibits, stand fittings, etc., brought onto the Fair premises.
- 3.3. The Organiser shall not be liable for damage or loss to the property of Participants caused by third parties, arising solely from the fault of the injured party, or resulting from failure to comply with the instructions issued by the Organiser's representatives.
- 3.4. The Organiser shall not be liable for items left unattended on the Fair premises. Participants shall have no claims in respect of the removal or destruction of unattended items carried out by the Organiser for safety reasons.
- 3.5. Participants shall be liable for damage caused to the Organiser's property.
- 3.6. The Fair premises are subject to monitoring and protection provided by the Organiser. Participants acknowledge that they are participating in a public event, and entry to the Fair premises and participation in the Fair is tantamount to consent to the recording, dissemination, and other use of their image or statements recorded during the Fair in visual or audiovisual form for the purposes of photographic documentation, documentary film, interview, and coverage of the Fair for statutory, documentation, marketing, promotional, or advertising purposes relating to the Fair and other events organised by the Organiser, as well as for the promotion or advertising of the Organiser and the Exhibitors themselves. 4. Conditions of Participation in the Fair

- 4.1. Persons present on the Fair premises (hereinafter also referred to as "Participants") are required to acquaint themselves with the content of the Regulations and comply with them. Entry to the Fair premises is tantamount to the acceptance of the Regulations.
- 4.2. Participants are required to follow the instructions and guidelines of persons responsible for organising the Fair, observe safety and public order rules, respect property, refrain from littering on the Fair premises, and behave in a manner that does not endanger the safety of other Participants or third parties.
- 4.3. Participants who are intoxicated, under the influence of intoxicants, behaving in a manner that endangers the safety of other Participants or third parties, disrupting the course of the Fair or violating general standards of conduct in public places, shall be removed from the Fair by security personnel or persons responsible for organising the Fair.
- 4.4. The following are prohibited on the Fair premises during its duration:
 - 4.4.1. hawking, understood as the sale of any products or provision of any services, including catering, other than those offered or accepted by the Organiser;
 - 4.4.2. distribution and handing out of promotional materials including leaflets, posters, and other information media, except those distributed by the Organiser and Exhibitors;
 - 4.4.3. political or religious agitation or demonstrations, protests, and other forms of public expression of views;
 - 4.4.4. display of books, recordings, audio-video materials, photographs, emblems, and other items on any device or medium that incite hatred, present false information, contain harmful or illegal content, or are offensive to third parties, their faith, or beliefs;
 - 4.4.5. bringing in or possessing weapons, fire-hazardous materials, explosives, pyrotechnic articles or other similarly dangerous items, alcoholic beverages, intoxicants, psychotropic substances, or other similar acting means and substances. The assessment and qualification of items as dangerous rests with the Organiser's representatives;

4.4.6. consumption of alcohol, intoxicants, psychoactive substances, or other similarly acting substances.

4.5. Participants under the age of 13 may take part in the Fair only under the supervision of adult Participants.

5. Final Provisions

5.1. All rights to the name and logo of the Fair are reserved for the Organiser.

5.2. The Organiser reserves the right to amend the Regulations.

5.3. Failure to comply with the provisions of these Regulations will result in the immediate exclusion of the Participant from the Fair.

5.4. The Organiser reserves the right to change the date or cancel the Fair due to unforeseen circumstances preventing its organisation.

5.5. To the fullest extent permitted by law, the liability of the Fair Organiser towards Participants for damages related to their participation in the Fair is excluded.
